### Updates:

### Future WATSA Meetings:

Almost all of this year's meetings are scheduled, with speakers lined up:

- October -- the Fall Retreat will once again be held at Mountain View Lodge in Manson.

#### **Membership committee**

We have had a large increase in our membership this year--up to 48 so far this year. An affiliate ATSA membership may be appropriate for many people in the community. Go to WATSA.org and register online.

#### **Policy / Legislative Committee**

The latest report by the Sex Offender Policy Board is soon to be distributed to legislative members. It addresses the SOPB recommendations for changes to SSOSA, including:

- To clarify who is eligible for SSOSA (that it is not just for family members),
- To look at a SSOSA-like sentence for child porn or other offenders based on level of risk,

- To reinstate / or revitalize the SOTP advisory committee,
- To seek elimination of lifetime supervision for non-revoked SSOSA completers.

A letter representing Dan K and WATSA was submitted to address a private request for the addresses of all registered sex offenders in WA state, including Level 1. The ACLU has taken an interest in the case, which has implications beyond WA, and ATSA has been involved as well. An injunction has been placed on the woman preventing her from launching her website. WATSA has discussed a letter in support of the State Patrol, who took up the case when the Attorney General passed on it. WA promoted the idea of community notification where it serves the public service. It could hurt that idea by diluting the effect of notification overall. Michael O and Dan Y will work to craft an official WATSA declaration.

### **Budget Committee**

Treasurer Linda Paxton reports we currently have a solid bank account balance of approximately \$21,955.31. There is an additional \$10K deposited today from the recent infusion of membership dues and fees, and conference registration, etc. Much of this money is earmarked for the upcoming conference. Right now we have approximately \$32K in the coffers.

### **New Business**

Ballots were distributed and votes were cast for the election of WATSA Board Members and positions. A new president (Paul Spizman) was elected, as were two new Board Members (Holly Coryell and Dan Knoepfler). Re-elected were Marshall Kirkpatrick (as Eastern Prerepresentative), Brian Judd, and Myrna Pinedo. Thanks to Jennifer Wheeler, who will continue her support as past president, and to Christmas Covell, for her loyal and hard work as WATSA Vice President for the past (at least) 5 years!! Welcome to the new Board members. We look forward to working with President Spizman!
