- Michael O'Connell provided an overview of the State of Washington SO POLICY BOARD which was adopted in 2008. SOSA 84 which is a special sentencing alternative for sentencing structure. He advised there are 12-13 members on this board to advise legislations with unanimous recommendations from the board. He indicated they have subcommittees that participate on various subject matters.
- Sexual Assault Task Force in Washington- Lisa recommended finding legislators who are interested in the subject as a first step. The task force currently meets at least one time per month.
- Lisa discussed that WATSA has considered hiring a lobbyist as a possibility and are currently exploring resources.
- Megan Reese provided an overview of the Special Commitment Center for civil commitment. Clients are required to have completed treatment, risk assessment is needed, as well as an annual review of risk.

WATSA outlined aspects of their board that is going well:

- New incoming board members
- 8-9 discussions per year for CE's that are held virtually for 2 hours every 3rd Friday of the month. Topics have included: chaperone approval, child forensic exams
- Consideration for a scholarship fund
- Diversity on board

WATSA needs are:

- Cultivating and nurturing relationship with DOC
- Reaching out to universities who are pursuing internships
- \$ into CD's for 6-12 months with a 4.5% return which requires disclosures in the minutes that all board members are in agreement with investing allotted monies.
- WATSA is in the process of re-writing bi-laws. Bill Davis provided feedback to keep it simple and avoid unnecessary details. Bi-laws are different than policies and encouraged WATSA to use ATSA as a guideline and change it to fit your organizations.
